#### 1: Introduction

Under the terms of the Procurement Reform (Scotland) Act 2014 public bodies with an annual regulated procurement value of more than £5million are required to produce an Annual Procurement Report, reviewing their procurement activity against the aims and objectives set down in their Procurement Strategy.

The purpose of the report is to record and summarise the actions taken by Cairn Housing Association to deliver the objectives of our Procurement Strategy and by so doing, complying with our key values of:

- Putting the customer first
- Aiming to achieve high quality outcomes for our customers
- Striving for excellence

This report covers the period between 1 April 2024 and 31 March 2025 and is presented as a record of Cairn's procurement activities during this period, showing not only how we have met our regulatory procurement requirements, but also how our procurement activity has facilitated delivery of Cairn's broader aims and objectives.

#### 2: Summary of Procurement Projects Completed in 24-25

Regulated procurement is defined by the Procurement Reform (Scotland) Act 2014 as public contracts for goods, services or works with a value exceeding specific thresholds, specifically £50,000 for goods and services and £2 million for works. The value of the procurement is measured over the total contract period, therefore a three-year contract worth £25k per annum is valued at £75k when awarded.

Even if no regulated procurements are made but total procurements for the year are worth £5m or more, public bodies in Scotland are still required to publish both their procurement strategy and a procurement report, with notification of publication (or copies of each document) to be sent to the Scottish Ministers.

While only six (out of thirty-six) procurements awarded by Cairn in 24-25 were regulated, the total net value of tenders awarded was £8,364,616.07, as per the table below:

## 3: Review of Procurement Compliance

Cairn are committed to ensuring that all its procurement activities, whether regulated or unregulated, are transparent, fair, inclusive and conducted in full compliance with both the Act and our own internal governance, including:

- Our Procurement Strategy
- Our Procurement Policy
- Our financial regulations
- Our Corporate Social Responsibility Policy

The routes to market specified in our Procurement Policy are based on the value of the required procurement, as per the table below:

Up to £5,000	A purchase order or works order must be completed and then authorised by the appropriate budget holder.			
Above £5,000 and up to £15,000	Minimum 3 quotations, unless of a specialised and limited supply – where a business case justification is required to the Senior Management Team.			
Above £15,000 and up to £50,000	Minimum 3 invitations to quote, submitted through Public Contract Scotland as a 'Quick Quote' selecting only from suppliers who have completed a profile. The order will be awarded to the organisation whose proposal is most advantageous to the Group with value, price and other relevant factors taken into consideration.			
Above £50,000, up to GPA thresholds	Competitive single-stage tender via Public Contract Scotland using the Single Procurement Document (SPD) Scotland.			
Above GPA thresholds	Two stage tender process using the Single Procurement Document (SPD) Scotland.			
Note: the above limits are the minimum required and, subject to the nature of the supply the Procurement Officer may determine that a higher process is the best option for a lower value supply e.g. two-stage process for a £75,000 contract.				

As can be seen from the routes to market listed on the page 2 and the requirements of the table above, all procurements in 2024-25 complied fully with our statutory obligations and our procurement policy.

It should be noted that the routes to market in the table above are defined by the *value* of the procurement and represent the minimum requirement for compliance with our policy.

However, procurement via a higher value route to market may be appropriate if, for example, a particular procurement involves a high level of risk. This scenario is ideally demonstrated by our procurement of a consultancy to assist in the development and implementation of our tenant engagement offering; while the value of this procurement was well within the range



for inviting three quotations via Quick Quotes, an open tender process was employed due to the strategic importance of this project and the desire to invite innovative ideas and solutions from as many bidders as possible.

It should also be noted that while there is currently no specific guidance on the use of procurement frameworks in our procurement policy, the mini competitions conducted in 2024-25 via the Scottish Procurement Alliance and Scotland Excel complied fully with Scottish public sector procurement regulations. A revised procurement policy, which includes a guide to the use of procurement frameworks and a proposal for an increased threshold for the procurement of works via Quick Quotes, has been drafted ahead of the Board meeting scheduled for May 2025.

As can be seen from the table on the previous page, the bulk of procurements in 2024-25 were for works on behalf of our Property Services department. While these works have significantly improved the quality of our housing stock, furthering our strategic aims of providing great homes and achieving high quality outcomes for our customers, few of our expired service contracts were renewed in the last financial year, meaning there has been only a small reduction in spend outwith contract – or Maverick Spend – compared to 2023-24. However, with the recent formation of a dedicated Compliance section within the Property Services department, tendering for new service contracts will increase in 2025-26 and the outcomes of these procurements will be included in future reports.

#### 4: Sustainability and Community Benefits

Sustainability, social responsibility and social value continue to feature prominently in our procurement process, with the sustainability credentials, added value, environmental initiatives and community benefits of bids received included in their evaluation. This has led to the appointment of suppliers and contractors who have demonstrated a strong commitment to apprenticeships and training, support for charities and community groups, fair work practises across their supply chains, ethical sourcing and commitment to initiatives including Net Zero. Cairn's membership of the Scottish Procurement Alliance again gave us access to match funding for our 2024-25 tenant hardship fund, allowing us to double our support for tenants experiencing fuel poverty or similar hardships associated with the high cost of living.

All added value and community benefit is proportionate to the scale and context of the procurement and takes account of the nature of the works, goods or services required and the size / resources of the winning bidder.

#### 5: Payment Performance and Support for Local Businesses

Cairn paid 82.1% of the 13,118 invoices it received in 2024-25 within 30 days. Cairn is committed to the principles of Fair Work First and promotes the payment of the living wage in all regulated procurements.

Cairn are committed to supporting and improving access to procurement opportunities for local SMEs and Supported Businesses. This commitment, together with the posting of all but one of the procurements listed on page two of this report on the Public Contracts Scotland website, resulted in the award of tenders to thirty-two SMEs in 2024-25. Particular attention is drawn to our Caithness Maintenance and North Voids Framework tenders, which between them resulted in six locally based SMEs being awarded contracts.



Cairn does not currently have any direct contracts in place with supported businesses. However, we are committed to inviting bids from supported businesses and request that bidders identify themselves as such on their Single Procurement Document (SPD) when submitting their tender.

#### **6: Continuous Improvement**

Cairn are committed to continuous improvement in our procurement activity. Therefore, as well as ongoing regular reviews of both our Procurement Strategy and Procurement Policy, Cairn is currently undertaking a Continuous Improvement Programme for Procurement (CIPP) review with Scotland Excel, with the first assessment scheduled for May 2025. The outcome of the CIPP will inform an action plan for improvement and updates on the progress of this action plan will be provided to our Board of Management and included in subsequent procurement reports.

#### 7: Future Procurements

Cairn anticipates its procurement programme will result in the following contracts being procured and awarded during 2025-26:
